MODENA | 26th January 2019

Pole dance is experiencing a fast development in Italy, reason why the organization of Italian Pole Dance Contest decided, in the last few years, to fully dedicate some space to the different strands that are the hallmarks of this discipline. From these needs have born "Exotic Pole Dance Contest" in 2016 and "Soul on Pole" in 2018.

Soul on Pole is the first competition entirely dedicated to storytelling, contemporary and cabaret pole dance. Competition will be divided into three main strands:

- CONTEMPORARY - participants may express their feelings with a contemporary mood
- STORY TELLING - participants may tell a story with their performance on the stage
- CABARET - participants may present a variety show using an humorist-sarcastic mood

Performers will be free to choose what to show and represent, with no technical and/or choreographic limitations. They could choose to use both poles or only one and leave space to imagination in order to create a performance free from any regulation limits.

APPLICATION DEADLINE

TO JOIN THE COMPETITION IT IS NECESSARY TO SEND A FULL-BLOWN APPLICATION FORM TO soulonpole@gmail.com NO LATER THAN 10th DECEMBER 2018 - Video Entry isn't requested.

Each category will admit 15 participants and 5 reserves. In case of less applications to some categories, organization may decide to accept more participants on others.

Applications will be real-time recorded on the web site www.soulonpole.com together with the chosen song.

COMPETITION CATEGORIES - DURATION OF THE SONG

Italian and foreigner performers are all invited to the Contest
Categories for each competition strand will be:

Participants can apply to more than a category, the chose of the correct category will be up to the performer and doesn't foresee any limitation, but organization reserves the right to move artists to a superior category in case of higher level, after prior notification.

Contestants will be evaluated by a jury with a 0 to 100 score using the following criteria:

There will be no compulsory elements, but choreography must results fluid; **the usage of both poles isn't required.**

While creating the performance it is possible to branch off and it will be allowed to carry objects and/or persons on the stage, there won't be admitted: animals, fire and liquids.

PENALTIES

- ◆ In case of prematurely leave of the stage before the end of the music, the performance will be considered as finished and evaluated up to that moment and it will be deducted a penalty of 20 points each judge on General choreography section (Contemporary), on Story section (Storytelling) or on Humor section (Cabaret)
- ◆ In case of accidental nudity each judge will apply a 20 points penalty on the image section, the performance will be interrupted on judge discretion.
- ◆ In case the song may result too long or too short compared to the regulation requirements there will be a 10 points penalty for each judge on General choreography section (Contemporary), on Story section (Storytelling) or on Humor section (Cabaret)

EVALUATION SHEETS

At the end of the competition it will be possible to ask to receive personal evaluation sheets **from January 28th to February 10th 2019** by sending an email to soulonpole@gmail.com while indicating: name, surname and participation category.

Cards will be sent after February 11th 2019.

PRIZES

In each category of the two competition mainstreams will be awarded:

- **I, II, III Place each category** (result of the total sum of points)
- **Special award from jury** (upon judges decision)

Awards of the single category will take place after the end of the category itself.

ENTRY ARRANGEMENTS

To join the competition it's necessary to send application form no later than 10th DECEMBER 2018.

Application forms must be filled and sent via email to soulonpole@gmail.com

Documents to be sent for the application:

- Application form and release for the usage of image completely filled and signed in every part
- Privacy form completely filled and signed in every part
- Membership request (only for those who haven't)
- Payment proof

SOUND AUDIO FILE

No later than 6th January 2019 all the participants must send the chosen audio file to be played during the performance. In case the file won't be sent within that date, the athlete cannot take part to the competition and will lose the application fee already paid. Files won't be given back in any case, organization can't be held responsible for the sent files.

On the competition day the performer must check-in handing over the followings:

- Picture showing the competition suit
- Medical certificate for non agonistic sport activities

In the absence of what requested, the organization must reserve the right to exempt the performer from the competition.

We suggest to bring an usb pen-drive with the file of the chosen song in case the organization may have some problems in reproducing the file received by email.

SPORT INSURANCE

This competition is organized by SSD Female Arts Studio S.r.l. affiliated to CSEN so the registration to the sport body lists is mandatory in order to participate to the competition. All the athletes already member of CSEN can take part to the contest, for the ones who haven't the card, it will be issued as insurance at the cost of € 25,00; **insurance is mandatory for all the participants of the contest.** Those who haven't the card must fill the associative sheet attached to the application form and pay € 25,00 + the application fee. **There won't be accepted applications with no CSEN card number stated or the payment of the insurance quote for who doesn't have one. IT ISN'T VALID SPORT INSURANCE RELEASED FROM ANY SPORT BODIES DIFFERENT FROM CSEN.**

For foreign athletes it won't be possible to issue any insurance coverage by the authority, so copy of personal insurance coverage valid outside origin country must be sent together with the application form.

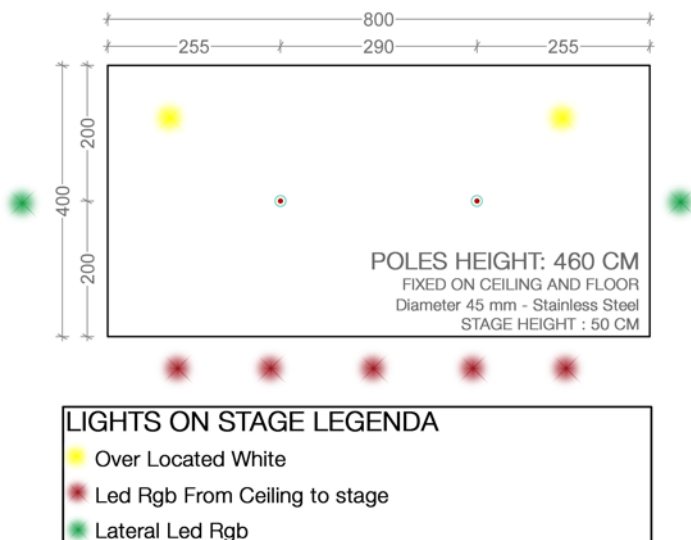
Location will be the competition hall with permanent stage inside Pole Dance Female Arts Studio facility, via Pico della Mirandola 40/E Modena.

STAGE REHEARSAL

The stage is permanently installed inside Female Arts Studio facility, it is possible to book rehearsals on week-days only upon reservation or during the dedicated weekends.
